Dear Khamis and Ramla,

I am sorry for the tardiness of this letter to thank you for meeting with me Sunday the first of June. Our family is honored to serve the members of your faith community, FVAMC, Inc. Our staff has extensive experience in service to the Muslim population of Connecticut and will do anything we can to meet any specific needs you may have as we discussed in our meeting. We will have a specific container with all the materials your team of washers will need and it will be available 24/7 in our sanitary preparation area. Our controlled temperature room is also available should the need arise for a longer period of time before burial. We will also make available our family center or larger service room for prayers and a service before going to the cemetery or, of course, we will bring the deceased to the Mosque on Harris Road if that is what you or the family would like. We are prepared to get the attending physician's certification on the death certificate, gather the necessary information from the family, and file to obtain the necessary burial permit so the burial can take place as soon as possible. I have included a copy of a CT Death Certificate and highlighted the necessary information.

We would provide our professional services for all arrangements and direction, staff and licensed facilities for washing/holding as well as our transfer vehicle and hearse, filing all necessary legal documents for burial, sending Social Security notification, and materials for washing, all performed within your timeframe providing a signed death is available. The total package is \$3,400. The only additional costs would be outside expenses such as grave purchase, digging grave, outer container at cemetery, certified copies of death certificate (\$20. each), obituaries, or transportation beyond 40 miles.
